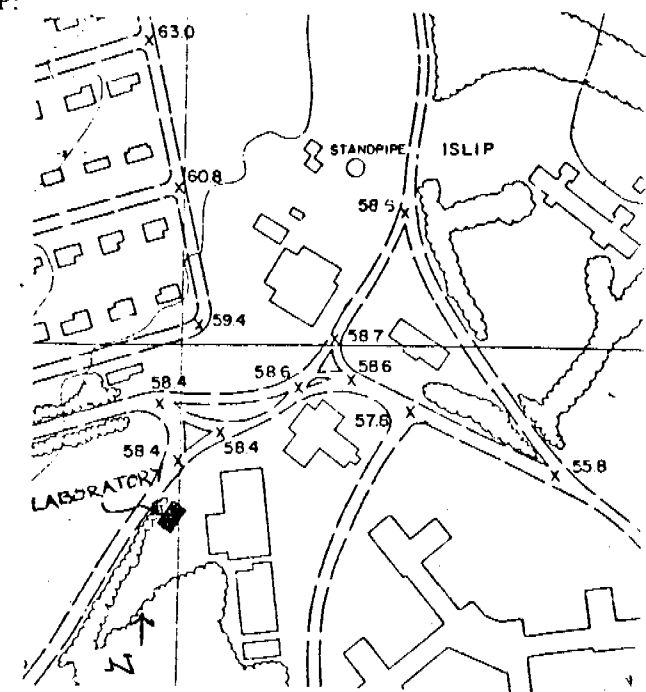

## 17. INTERRELATIONSHIP OF BUILDING AND SURROUNDINGS:

Central Islip State Hospital is located on a 1000 acre wooded property, running from Clayton St. to Southern State Parkway, on both sides of Carleton Ave. The grounds contain buildings from various periods and in various architectural styles, including Tudor and Colonial.

## 18. OTHER NOTABLE FEATURES OF BUILDING AND SITE (including interior features if known):

This one story brick building has a slate roof and decorative exposed rafter ends. It has a hipped roof with projecting gabled vents. The nine-over-nine windows have lugsills. There is a four pane transom above the front door. The basement is partially above ground, and has an exterior entrance.

## 20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:

This building was originally the Laboratory for the Central Islip State Hospital. In 1913 an important discovery, referred to as "The Breakthrough" took place here. Dr. J.W. Moore and Dr. Neguchi established the connection of general paresis with syphilis by discovering the spirocheta pallida in 12 out of 70 brain studies. After use as the Laboratory, the building became a photo lab. It is abandoned at present. But the one story brick building has its original slate roof, exposed rafter ends, and architraves.
