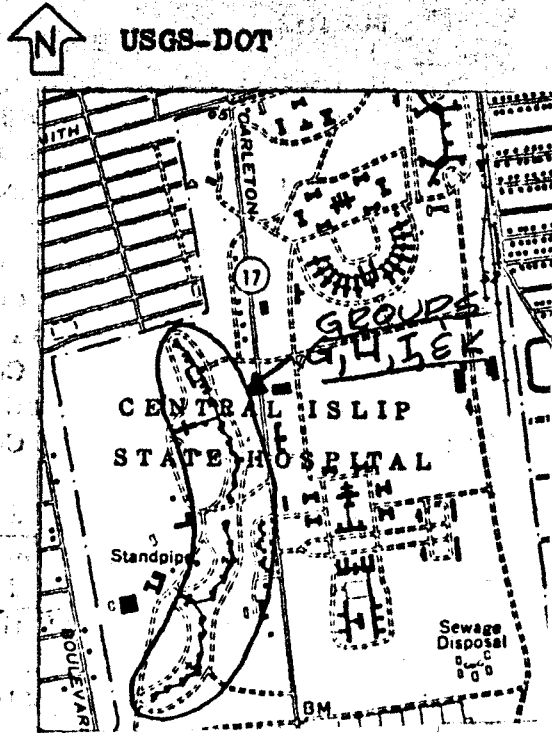

Fine brick work. Arched windows. Good proportions. Granite course at water table. Granite sills. Wood work at Porches. Dramatic Interplay of geometric forms in massing of buildings. Hipped roofs with dormers. Original windows, doors, and hardware.

20. HISTORICAL AND ARCHITECTURAL IMPORTANCE:
Central Islip State Hospital Building groups G, H, I, & K were originally known as the "String of Pearls." These handsome brick buildings composed of geometric forms, carefully positioned to one another, were constructed in 1901 as a part of the South Colony of the development. The Central Islip State Hospital was first constructed in 1887 as a New York City Farm Colony Hospital. It was taken over by the State of New York in 1896. The Central Islip State Hospital was the largest of the State Institutions. The "String of Pearls" can be found on a 1915 Atlas of Central Islip. Today they stand empty.
